VIII. WEB Presentation – Middle School

XII. Rescind Policy 2264 – Non-Discrimination on the Basis of Sex in Education Programs and Activities

Rescinding Policy 2264 would put the District's previous Title IX policy adopted in January 2024, Policy 2266, back in place. This is due to a Federal court ruling in January, 2025 striking down new regulation put in place during the Biden Administration.

XIV. Approval of New Middle School LMC HVAC Rooftop Unit
